## Mr. Joe Burlingham, River League Coach

- Tryout process: great for fall
- Suggestion to funnel through with SOBA in the fall, then all set for Spring RL
- Full registration each fall, just not those trying out

#### Ms. Rachel Moore, parent

- Have there been previous AGM's
  - Yes, conducted annually at this time.
- Minutes on website
  - o We were experiencing a technical glitch, all minutes are now available

- Financials for AGM
  - Possible to have posted prior to the AGM
  - Believes WMB is a registered not for profit (clarity was provided that while we are working towards this status we currently do not have it)
- 2018 Fundraising Fee
  - Explanation was provided by Lana to how the expenses and return on fundraising is recorded
- Pants Fee on financial statement
  - Previously the Lady Wranglers pants were purchased through WMB, and paid back
  - This is no longer a WMB finance practice, players are responsible to purchase and provide their own pants.
- 2017/2018 equipment Fees on financial statement
  - While we have base equipment, we often have to replace to keep a good base for each team
  - Baseballs are more expensive then most realize
- Fiscal Year End?
  - o We run Jan Dec.

#### Mr. Joe Burlingham, River League Coach

- Equipment for Umpires?
  - Yes, each home team to provide the umpire with this
  - o Will look into better explanation for coaches in 2020
  - Gear is at Canton & Centennial. Petrolia diamonds do need sets, possibly at Kerr
  - Will add into Coaches manual
- Bridgeview Flats Diamond: this is an excellent diamond resource to have, great that it is lined and set up in advance. Better benches and possible red dirt would be great.

#### Mr. James Weir, assistant coach

- Concern with 4 Sarnia kids making the PeeWee OBA team, this took away spots from WMB kids
  - Possibly look to only open up to other Centres if a full team can not be made from our own centre. WMB kids are typically here for life, out of centre kids come and go which uproots the momentum of a team.
- OBA PeeWee Tryouts had extensive kids
  - o Maybe 2 groups in future
